COURSE CERTIFICATION

The AWS modules are internationally accredited by AWS. SGS is an entity accredited by the AWS to offer this course.

The issuance and delivery of certificates will be made within a maximum period of fifteen (15) days after completing the course, having processed the attendances, participations and evaluations.

The certificate will be issued under the following modalities:

- **Participation:** The course attendance will be considered, as long as it is greater than or equal to 75% of the duration of each independent module.
- Approval: Those participants who were successful in the continuous evaluation (participation, punctuality, aptitude and performance) will be considered as approved.
